





HOW WE SERVED OUR CLIENTS THIS YEAR






AGE OF THE CLIENTS WE SERVED








RACE OF THE CLIENTS WE SERVED





EDUCATION LEVEL OF THE CLIENTS WE SERVED











During the 2020 - 2021 fiscal year, The PROGRAM observed marked decreases in the income levels of the clients it served. The COVID-19 pandemic and associated unemployment rates throughout the fiscal year clearly provided additional financial challenges to the clients The PROGRAM serves. Despite the challenges, this fiscal year was successful in highlighting the importance of providing supportive reentry services in order to aid clients in managing difficult and challenging situations.

COGNITIVE BEHAVIORAL INTERVENTION





The PROGRAM's Cognitive Behavioral Intervention program is built upon an evidence-based curriculum that aids clients as they transition home from incarceration. During the Cognitive Behavioral Intervention program, clients explore topics including establishing and maintaining healthy relationships, exploring the ripple effects of responsible and irresponsible behavior, improving communication, managing difficult feelings, individuals' abilities to change how they think in order to alter their attitudes and behaviors, and strategies to help stay on track with positive changes and prepare for warning signs that could lead away from positive change efforts.


Celebrating Accomplishments


FAMILY REUNIFICATION





Empowering Parents & Strengthening Families

The PROGRAM implements evidence-based strategies to meet the unique, gender-specific needs and challenges of parents returning home after incarceration. Because every family is different, our philosophy is not "one-size-fits-all." We tailor our services around the unique needs of our clients. Our flexibility allows for individualized sessions for clients, their children and family members. Our evidence-based parenting curriculum allows trained staff to provide comprehensive assessments, regular evaluations and sessions; parenting classes, parent support groups, family support groups and spousal or significant other groups; goal setting, emotion regulation and parenting strategies for different age groups. Staff at The PROGRAM work to meet the individual, unique needs of each and every family by offering flexible scheduling, coordination to satisfy court-mandated stipulations and specialized sessions or groups when necessary.


A New Partnership For York County Women

Documented repeatedly in criminal justice, social science, and behavioral health literature, the greatest challenges to sustainable reentry are housing, transportation, education / skill development and employment, health, and access to wrap-around services. Integral to a reentrant's success is family and community support across public, private, and nonprofit sectors. Project ReEntry York County – an ideal collaborative initiative – aimed to go far to address these needs and reduce recidivism. In early 2021, The PROGRAM embarked on a new and exciting partnership with York County Prison, York County Probation and the York County Reentry Coalition in order to bring family reunification services to women involved with the criminal justice system in York County. The goal of Project ReEntry York County is to provide reentry services, including individualized case management services, gender-specific parenting classes and connections with Mentors in the community in order to support women as they rebuild their lives after incarceration.

At the core of this program lies the Parenting Inside Out (PIO) curriculum, which is the only parenting program in the country developed for justice-involved parents. Its outcome-and evidence-based curriculum was built by psychologists on cognitive-behavioral parent management skills training and includes role play effective communication, practice on emotion regulation, and establishes pro-social goals. Developed during a six-year collaboration of scientists, policymakers, practitioners, and instructional designers, PIO was informed by research and practice. Since a dysfunctional family is among an offender's greatest criminogenic risk factors, Parenting Inside Out training will have cost-effective benefits for participants that transcend generations.


Closing Housing Gaps In York County

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act was signed into law. The CARES Act implemented a variety of programs to address issues related to the onset of the COVID-19 pandemic and was signed to help the Nation respond to the coronavirus outbreak. The CARES Act allocated resources to be used to prevent, prepare for, and respond to the coronavirus pandemic (COVID19) among individuals and families who are homeless or receiving homeless assistance; and to support additional homeless assistance and homelessness prevention activities to mitigate the impacts of COVID-19. The PROGRAM was successful in becoming a service provider for related housing assistance services to benefit individuals in York County that have been involved with the criminal justice system within the last two years.

The PROGRAM's implementation of this new housing assistance program contains two types of financial rental assistance - Homeless Prevention and Rapid Re-Housing. The PROGRAM's Homeless Prevention program aims to serve individuals and families who are at-risk-of-homelessness in order to help them maintain their residence. The PROGRAM's Rapid Re-Housing program targets stabilizing homeless individuals and families in a stable housing situation as quickly as possible and providing wrap-around services after the family or individual obtains housing. Both programs coordinate and collaborate with York City and the York County Continuum of Care Committee in order to effectively meet the needs of clients and adhere to established program parameters.

We Rise By Lifting Others


Our Mentoring program strives to provide our clients with the opportunities to strengthen their lives by building trusting relationships with Mentors who offer guidance, encouragement and non-judgmental support. The PROGRAM values and respects the dreams, visions and goals that our clients develop as they strive to become positive and productive citizens in our community. Staff-assisted goal planning provides clients with available resources to promote a stable family structure and successful route toward self-sufficiency after incarceration. Clients are able to take part in one-on-one, group or combination sessions while participating in mentoring services with The PROGRAM.



"Leaving prison after 24 years was like landing in another country with nothing but the clothes on your back...minus the clothes on your back. I was terrified that I'd forever be judged based upon my worst moment; that I'd never be accepted back into society. It felt like I had a tattoo on my forehead that read "Excon." Out of fear, caution, and a bit of hope, I enrolled in The PROGRAM. In retrospect, it was one of the best decisions I made. I was teamed up with a Mentor, Keith, who has helped me in so many ways. Keith listens to my concerns, lends invaluable advice / guidance, and connects me to resources I didn't know existed. I've been out for nine (9) months now, and am doing great. I am employed, compliant with all the rules of parole, and have a strong support system. If not for The PROGRAM, I may have fallen into the cycle of recidivism that sends 75% of offenders back to prison. Because of The PROGRAM, I am proof that successful reentry is possible with adequate resources." - Kurt D., Mentoring Client

WORKFORCE DEVELOPMENT





Tackling Employment Barriers

Our Workforce Development program strives to eliminate barriers associated with securing and maintaining employment for our clients. We are able to provide a wide range of services including assistance in acquiring forms of identification; assistance in acquiring a GED or High School Diploma (in partnership with affiliates); work-related transportation, interview clothing, work uniforms, steel-toes boots, two-way radios and non-slip shoes, when required.

Using Technology To Make New Connections

On Monday, June 21, 2021, The PROGRAM participated in a Virtual Reentry Fair hosted by the Pennsylvania Department of Corrections that was broadcast live across the state's State Correctional Institutions. During the Virtual Reentry Fair, inmates currently incarcerated in the state's system were provided with opportunities to obtain information from employers and service providers throughout the state. Incarcerated individuals were also provided an opportunity to ask questions, in real-time, to employers and service providers and receive answers to better prepare for their return home after incarceration. More than 230 incarcerated individuals tuned in to the Virtual Reentry Fair and The PROGRAM received dozens of letters following the event. Following the Virtual Reentry Fair, satisfaction surveys were provided to inmates who attended the virtual session and The PROGRAM is proud to report that it was was listed as "most beneficial" on many inmate surveys.

Expanding Capacity & Supporting Youth

In early 2021, The PROGRAM expanded its reentry work to include providing reentry services to youth clients being released from one of Pennsylvania's state-run secure juvenile justice facilities. The PROGRAM's Youth Reentry Coordinator works directly with youth clients and their families during the reentry period to establish and implement a viable aftercare plan, coordinate access to supportive services, and ensure school enrollment and stability. Youth aftercare plans focus on family / guardian / kin supports; probation; behavioral health needs; school enrollment and stability; community-based or extracurricular activities; and any other area of need for the youth client and / or the youth's family.
